

Honoring Families with TEXAS HERITAGE PIG PRODUCTION

PIG PRODUCTION REQUIREMENTS

1. Pigs must have been continuously owned and produced by family members for two or more generations for at least 50 years.

OWNERSHIP REQUIREMENTS

1. The line of ownership from the first family member producing pigs to the current owner(s) may be through wives, husbands, children, grandparents, siblings, aunts, uncles and cousins. Adopted children will be recognized equally with biological children. The line of ownership and approximate dates of ownership need to be included in the application.
2. Any pig production that has been sold or is in the process of being sold or leased to a non-relative is ineligible.
3. Owner or co-owner must actively manage and direct the everyday pig operation of the farm. Absentee ownership of production does not qualify.

APPLICATION REQUIREMENTS

1. Please answer all questions on this application. Make copies of the appropriate pages for additional owners to complete.
2. TPPA will provide one Heritage Pig Production certificate to each family that is recognized. Additional certificates are available upon request.
3. Include information on all owners and co-owners.
4. Once an operation has been recognized, it will not qualify for another certificate until the operation has changed ownership to another generation of family members. If family members have developed separate operations from the founder's operation and they meet all the program requirements, each owner may apply separately for the program. For example, Hiram Johnson willed each of his three children a portion of his operation and their descendants continue to produce separately. Each descendant's farm can apply for the program.
